



INSTRUMENT OF GOVERNMENT

HAMPTON LUCY CHURCH OF ENGLAND PRIMARY SCHOOL & NURSERY

1. The name of the school is **Hampton Lucy Church of England Primary School and Nursery**.
2. The school is a Voluntary Controlled school.
3. The name of the governing board is "**The Governing Body of Hampton Lucy Church of England Primary School and Nursery**".
4. The governing board shall consist of:
 - 2 **Parent governors**
 - 1 **Local Authority governor**
 - 1 **Staff governor**
 - 1 **Headteacher**
 - 3 **Foundation governors (including ex-officio governor)**
 - 4 **Co-opted governors**
5. The total number of governors will be **12**.
6. The term of office for all governors shall be **four** years.
- 7a. Foundation governors shall be appointed by the Coventry Diocesan Board of Education in consultation with the Parochial Church Council **of St. Peter ad Vincula**.
- 7b. The Diocesan Director of Education and the appropriate Archdeacon shall be entitled to appoint a foundation governor to act in the place of the ex-officio foundation governor whose governorship derives from the office named in (a) above, in the event that the ex - officio foundation governor is unable or unwilling to act as a foundation governor, or has been removed from office under regulation 21(1) of the Regulations.

8. The Diocesan Director of Education and the appropriate Archdeacon are entitled to request the removal of any ex-officio foundation governor and to appoint any substitute governor.

9. Statement of Religious Ethos:

Hampton Lucy Church of England Primary School and Nursery derives its ethos from its Christian values:

This means that every member of our school community, of whatever faith or ethnicity whatever their status, from our Headteacher to the youngest child in the nursery class is valued equally; all are equal in the sight of God.

To enable each of us to flourish we encourage good manners (these are based on consideration of others) unselfishness and an ethic of service. In such an atmosphere each of us can learn without fear; dare to take initiatives; believe in ourselves and therefore succeed in our education which is, of course, the focus of our school.

This approach of thoughtful, shared endeavour applies to schoolwork, sport, music, drama and in all dealings with each other, in or out of school, we are a community.

10. This Instrument of Government comes into effect on **14th February 2020**.
11. This Instrument was made by order of Warwickshire Local Authority on **13th February 2020**.
12. This variation takes effect on **14th February 2020**.

A copy of this instrument must be supplied free of charge to every member and associate member of the governing board (and the Head teacher if not a governor), as well as, the trustees of the foundation of the school and the Diocesan Director of Education for Coventry Diocesan Board of Education.
